Each dancer will also need to bring a secure **water bottle**, **healthy snack** and dance shoes in a dance bag to each class. Dancers are not allowed to wear their dance shoes as **street shoes** when arriving to or leaving from the dance studio. Additionally, Spotlight Dance NOLA faculty and staff would prefer that the girls wear **black leggings** and their **Spotlight Dance NOLA tshirt** over their dance clothes upon arrival and departure from the studio.

Dancer/Parent contract

Attendance:

Each dancer is allowed 3 unexcused absences before the teacher has the authority to remove them from performance eligibility.

Excused absences include medical and family emergencies and require a doctor's note or other proof of occurrence.

Punctuality:

Each dancer should arrive at least 5 minutes prior to class time.

If a dancer is more than 15 minutes late to class, the teacher has the authority to ask that they sit and observe the remainder of class.

Uniform:

Each dancer must comply with the dress code specified for their class genre.

Each dancer must wear their hair in a bun or pony tail for class.

No dancers are allowed to wear jewelry to class.

If dancers receive more than three uniform infractions from a teacher they may lose performance eligibility.

If dancers are out of uniform, teachers have the authority to ask them to sit and observe class.

Food/Drink:

Each dancer may have bottled water and a healthy snack for class.

There are no colored drinks allowed in the studio.

There is no gum or candy allowed in the studio.

Commitment Clause:

Registration is per semester although tuition may be paid monthly, All SpotlightDanceNOLA students and parents must acknowledge commitment to complete each semester. By acknowledging this, students and parents agree that if dancers choose not to complete the semester and refrain from attending SpotlightDanceNOLA classes that a \$100 commitment cancellation fine must be paid upon cancellation of commitment.
